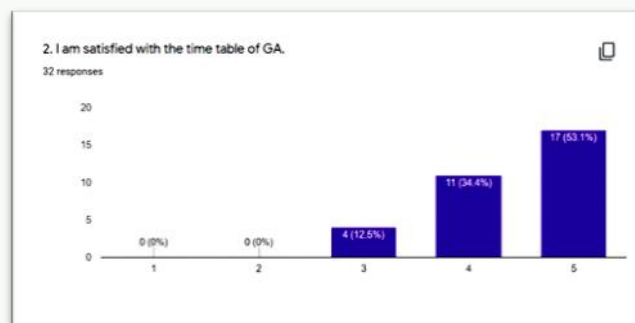
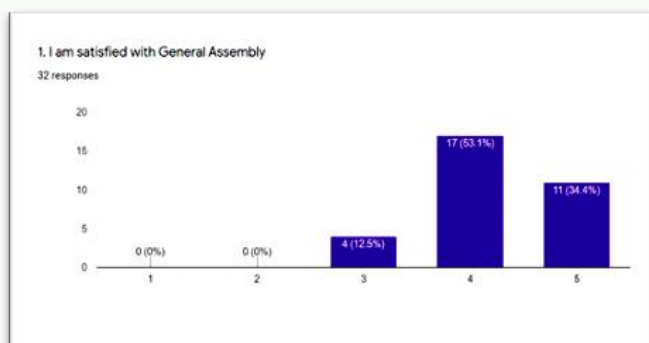

A questionnaire was offered at the end of the GA to hear your votes on what we offered on the online GA. The questionnaire was given online (which we can say is an advantage of working online).

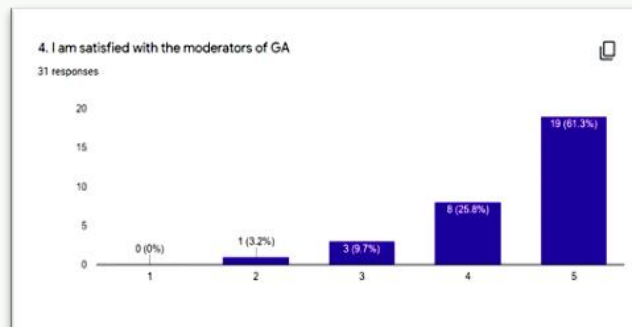
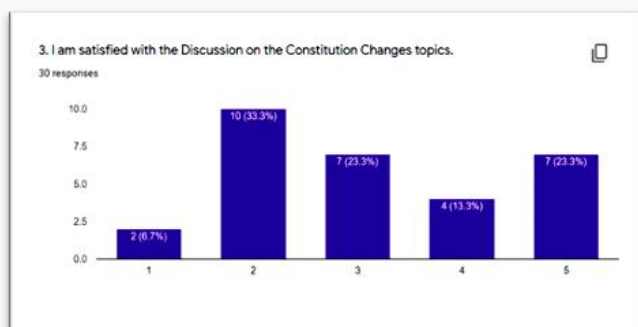
1. I am satisfied with the General Assembly The first question was answered by 32 members, 11 members are completely satisfied by GA, 17 are satisfied and 4 are undecided.

2. There are 30 responses When asked about the time frame 17 are completely satisfied, 11 are satisfied and 4 are unspecified.



3. I am satisfied with the Discussion on the Constitution Changes topics. There are 30 responses 7 are completely satisfied, 4 are satisfied, 7 are undecided, 10 are dissatisfied and 2 are completely dissatisfied.

4. With the moderators 19 members are completely satisfied, 8 are satisfied, 3 are unspecified and 1 is dissatisfied. There are 31 responses.

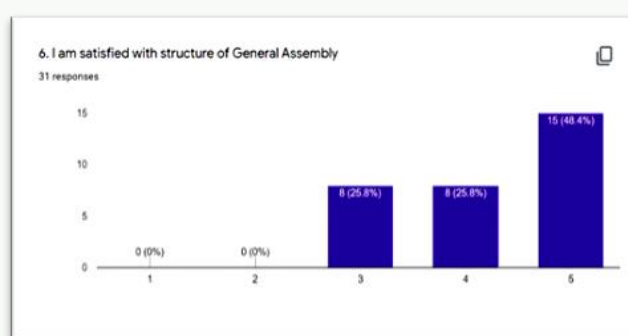
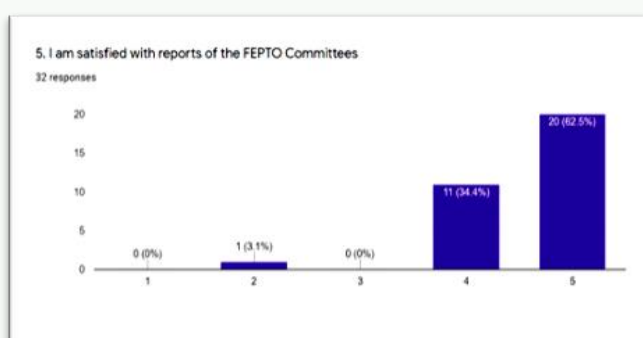

8. These are 19 responses on the question "What could be done differently Regarding the voting"?

It wasn't clear before the meeting that only one person could vote. That was a shame. Because then I would have been the representative of another training organisation. All results should be presented at the same time. Sent the voting procedure a few days before the GA, in case of on line voting. Give more possibilities for the answers (Yes, no, yes for a test period, abstention, a poll to check the opinions). Nope

9. These are 18 responses on the question "What could be done differently regarding the structure?"

It was fine. The chat issue. More time for Constitution. No comments. It is O.K. there could have been titles. Breakout rooms for some discussions.. Discussion about changes in constitution should be a first point. More minutes for discussion and questions. There should be a structure that gives more place to exchange of ideas. Needed more time for the discussion. There should be more room for the voice of people who do not speak often or at all during the GA, etc. The group dynamics of the large group should be respected and followed.. Give 4 hours to the constitution. It is more important than all other topics combined. I think this is also the place for discussion. And there was no time for that. Good as it was. Most important topic in the morning. Nope

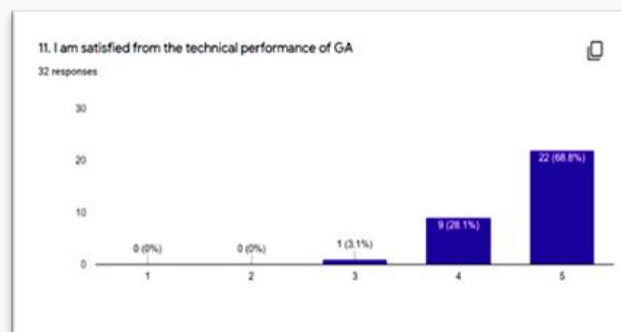
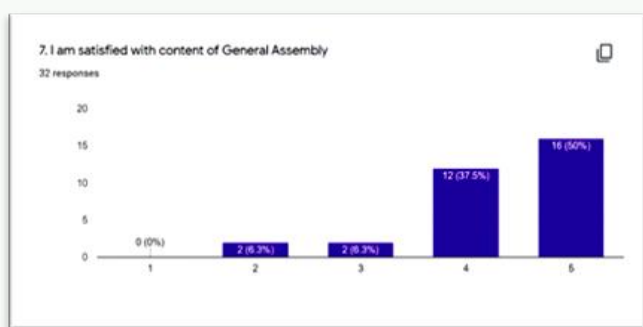

10. These are 15 responses on the question "What could be done differently regarding the content?"

It was satisfactory. Fine. Everything was good. It is O.K. It was ok. ?. Too many changes are brought up, we think this is problematic. The content gave us many answers, but more questions. The discussion about what psychodrama, sociometry and group therapy is. Even in the suggested changes in the constitution the triad of Moreno was not defined in a correct way. - Clinical psychodrama is another topic that seems to be in a minority position lately at FEPTO. We need to give room for more clinical examples, cases, presentations, etc. See item 9. The first part has to be done but it takes a lot of the time which could also be used differently. One or two questions could have been discussed in small groups, as Zoom gives that opportunity. The proposal for the 60 hours of research instruction and also 40 pages for a written piece of quality work could have been better accepted after a trial period (i.e two years). So make a possibility to vote yes for a try out! In general: we rather go for quality instead of quantity: therefore look for quality-criteria (such as "worth publishing" -evaluated by two PD-experts). Rather 15 brilliant pages than 40 pages of dull (and repeated, but well researched) text!

11. "I am satisfied from the technical performance of GA" On this question, 22 are completely satisfied with the technical performance of the GA, 9 are satisfied, and 1 is undecided.



12. These are 12 responses on the question "What will you do differently?"

All, is O.K. As hosts more often are. Mute some of the participants.. maybe discussion 15 min in small groups. We will consider the constitution carefully. In the zoom meeting with so many participants it is really hard to have a real discussion. I hope for the next meeting when we will be together in Ohrid to have enough time for meetings and for discussions. I would zoom out the presentation while there were shared screen presentations in order to be easily seen and read. I would spend more time and divide the group into smaller topic centered discussion groups. When people are asked to introduce themselves they can maybe do that very shortly. Next time when we see each other we could save time to have AM on Zoom after the meeting. Then we can use the time for more personal talk when we meet. Sharing experiences and develop friendships. For Constitution changes use trial periods! Don't try to invent regulations for eternity!

13. These are Suggestions about topics for next Annual Meetings (13 responses)

Training standards - change of hours in competencies. More committees, constitution, how to share the Council duties with us. Psychodrama and Sociodrama Training. Countries should not interfere with each other's training, foreign trainers cannot open training, but they can be invited for workshops if there are already many educational institutes in a country. Training standards Constitution Psychodrama in social domain and community crisis. Clinical psychodrama. Constitution constitution constitution. One representative per institute if is possible in every Committee. Training hours changing for competence result in psychodrama education. How do we want Fepto to develop? What is the vision for the future? Can we have a common project that is not focusing on therapy? Moreno's vision is much broader than that!. Think about a possibility to link different institutes to each other in an informal way: make meeting tables, where they can come to appointments-on-line regarding: content, methods, techniques, action forms, written materials, etcetera; They can probably exchange trainers, literature, and hand outs in a later phase. Don't make formal FEPTO-clubs, but only FEPTO fire places on line!.

14. There are 25 responses: How do you feel about the postponement of the Conference and AM for next year
